A status report of current picture of the state along with the agenda of the meeting was presented.

Following Decisions were taken in the meeting by the Committee:

 As per the provisions under the Act Importers/Manufacturers/Vendors/Sales firms etc. will send the Total number of USG machines sold in the State on Quarterly basis. A unique id and password will be issued to the Importer/vendors/sales firms for uploading the same on www.ukhfws.org website.

- 2. Importers/Manufacturers/Vendors/Sales firms etc. will also send the Total number of USG machines purchased under buy back scheme from the registered USG Centre in the State on Quarterly basis. A common format for both sale and purchase (including buy back) of the ultrasonography machines will be made for easy and timely reporting and will be uploaded on the ukhfws.org website.
- 3. A decision with mutual consent was agreed between the Importers/Manufacturers/Vendors/Sales firms etc. and the Committee members to make a website portal displaying list of Authorised & Registered Ultrasonography machine Vendors/sales Firms for selling the Ultrasonography machines in the Uttarakhand State ( as the same practice is already being followed successfully in the Maharashtra State).
- 4. Decision was taken to empanel the Dismantling Companies for old ultrasonography machines (whether in working / non-working condition) purchased from registered ultrasonography centres for dismantle purpose. These companies will be Authorised & Registered for dismantling the old sonography machines in the Uttarakhand state; and will present the Affidavit before the State Appropriate Authority PCPNDT Uttarakhand that such & such machine has been purchased from the registered ultrasonography centre for the purpose of dismantling and the said machine with Serial No---, Make No---- and Model No-----Registration No--- has been dismantled successfully and it's no part (including probes & motherboards) has been left un-dismantled. The said company will be held responsible for any discrepancy if arises in future in regard of the said machine or its part found elsewhere.
- 5. The dismantling company will also send the list of the ultrasonography machines dismantled (purchased from Uttarakhand state) with Serial No---, Make No---- and Model No----, and previous Registration No--- etc. to the State Appropriate Authority, Uttarakhand.
- 6. Importers/Manufacturers/Vendors/Sales firms etc. will ensure the sale of portable ultrasonography machine to centres which are providing in-house indoor patients services only and also send the list of Portable USG machines sold in the Uttarakhand state to the State Appropriate Authority, PCPNDT, Uttarakhand.
