DON'T IN PCPNDTACT

- ❖ Never do Sonography at unregistered place because new Rule 11 (2) is changed & you will be punished under section 23. Never Give your Degree certificate, permission letter to any polyclinic or BAMS ,DHMS drs to whom you don'ts have a trust for registration of their clinic under Pcpndtact.
- ❖ Portable sonography is banned so never do it at any nearer or far place even on request.rule 3
- ❖ Do not hesitate to refuse or Do not promote to do sonography at polyclinic run by unknown ,untruthful BHMS,DHMS or unauthorized person. Because in your absence at that clinic if he/she may do sex determination by its own or help of other & if his/her machine is sealed you are equally liable for crime) so better to avoid visiting as a sonologist at such place.
- ❖ Do not do sonography at more than two places at one district without informing authority(time hours & day)please note there is stay in this amendment by high court of certain state but this stay apply at only & only that state(e.g. DELHI) other state has to follow new amendment. Rule 3
- ❖ Do not employ unqualified person at your clinic

DON'T IN PCPNDTACT

- ❖ Do not encourage patient or person(agent)for sex determination by you or staff so any such enquiry come, prior strict instruction to your OPD staff not allow entry of such in your consulting room .
- ❖ Do not forget date of your renewal of PNDT registration
- ❖ Do not make any stylish change in original prescribed FORM—F as per the provision of Pndtact Section 4 B Rule 9 (4) Rule10(1 A)
- ❖ Do not forget monthly report on form F before 5th- of next month
- ❖ Do not make any change in sonography unit, place, or management without written application in duplicate a one copy with you or permission of authority in writing (**prior intimation to appropriate authority before 30 days of expected change**)
- ❖ Do not sale sonography machine to unregistered place, agent or **Do not buy from unauthorized agent or person or unregistered centre, inform authority about your selling of machine in prescribed manner.**

DON'T IN PCPNDTACT

- ❖ Do not do sonography without written declaration of patient in FORM –F with original signature on all 2 FORM-F.
- ❖ Do not publish any advertisement relating to preconceptional **sex selection** or prenatal sex determination violate section 22 .
- ❖ Do not ignore any new direction or amendment by government authority in PCPNDT act.
- ❖ Do not involve **in** any anger or misbehavior with authority when they visit for routine inspection at your clinic.
- ❖ Do not tamper any records after notice issued by Government authority against you in case of violation of PCPNDTACT.

DON'T IN PCPNDTACT

- ❖ Do not send sample of biopsy, fluid to unregistered laboratory in case of invasive procedure's chorionic villous sampling, amniocentesis etc) Laboratory should also be registered under PCPNDT act
- ❖ Do not forget to send written report of FORM-F---- NIL OR ZERO (even if you do not do single sonography in that particular month)
- ❖ Do not forget to inform Government authority in written acknowledgement in 2 copy with seal & sig of authority that I will be unable to send monthly FORM-F report in event if you planning to visit abroad for 2 to 6 month foreign tour so I put my Sonography machine in safe custody in my premises(locked in my room), keep one copy with you will save you in case of notice issued against you by A.A. for not sending report of form f
- ❖ Never allow your hospital staff to sign in PANCHNAMA as a witness in a event of sealing of your Sonography machine.
- ❖ Never confess or admit, sign on panchnama that you has done a mistake write e.g. I reserve my Right To Defend my case. (because your first confession make it very difficult for you in court of law to prove you innocent)
